Choosing parameters

- ▶ The only mandatory field is **Review Date Range**.
- ▶ Additional filtering choices are:
 - ▶ OSP – If you have rights to more than one OSP you can limit your selections to one or more OSP.
 - ▶ Service Point – if you want to limit your report to one or several service points
 - ▶ Inspector – one or more individuals
 - ▶ Review Inspector – one or more individuals
 - ▶ Commodity – one or more grains/classes
 - ▶ Factor – one or more factors
 - ▶ ** if you want a particular factor {example DKT} over several commodities then you'll need to:
 - Pick one commodity
 - Press Refresh for the Factor list
 - Choose one or more factors {DKT}
 - Back in the commodity box, remove all commodities
 - ▶ Your report will now be for that factor {DKT} in all commodities


